Treasurer's Report 12-31-2013

- 1. To summarize, the cash flow for the third fiscal quarter of the 2013-2014 year we received \$23,692.21 in income from dues and event income and \$25,234.46 in total expenses. This amounted to a loss of \$1,542.25. This loss is much less than the normal \$10k loss figure we typically see in this slow fiscal period. We had some good income from Oktoberfest. If we look at the overall picture we are looking real good as we are over \$97,000 in income and we still have the major part of Dues and Spring Conference fees to look forward to. We should hit our projected \$156K in income this year.
- 2. Oktoberfest final report is in the package.

- 3. I am preparing letters to be mailed out this month for the donations that were given during Spring Conference and Oktoberfest. Records are much better than we had last year so I should go much quicker even with the increase in donations.
